Yearly membership dues are \$100.00 per each prospective member. Full membership dues are to be paid at the time of application. Points will begin to accumulate when membership dues are paid. There are no payment plans available.

1. Each contestant is required to sell \$100.00 worth of raffle tickets. The winner of the raffle will be drawn and announced at the TJRA Finals Awards Ceremony. In order to compete at the Finals all contestants must pay the \$100.00 of raffle ticket money. ALL RAFFLE TICKET MONEY WILL BE DUE THE SUNDAY OF THE JUNE RODEO. If your raffle money is not turned in at or before this time the contestant will drop all points

accumulated. The contestant may begin accumulating points after the \$100.00 raffle ticket money is turned in.

2. All Finals contestants MUST bring an auction item of \$25.00 value for the silent auction to be held at the TJRA Finals.
3. In order to qualify for the TJRA Finals a competitor must compete in at least 10 of the 16 rodeos and be in the top 15.

Being fully aware that participation in TJRA rodeos will expose said member to substantial and serious risk of property damage and/or personal injury or death, said member releases TJRA sponsors and TJRA directors, employees and agents of each entity or organization from liability for any and all property damage, personal injuries or other claims arising from participation in TJRA rodeos, including any time in the future, directly or indirectly, commence or prosecute any action, suit, or other proceeding against the before mentioned arising out of or related to the actions, causes of action, claims and demands hereby waived released or discharged by TJRA member. This provision shall be binding upon each TJRA member, his/her spouse, legal representative, heirs, successors and assigns".
